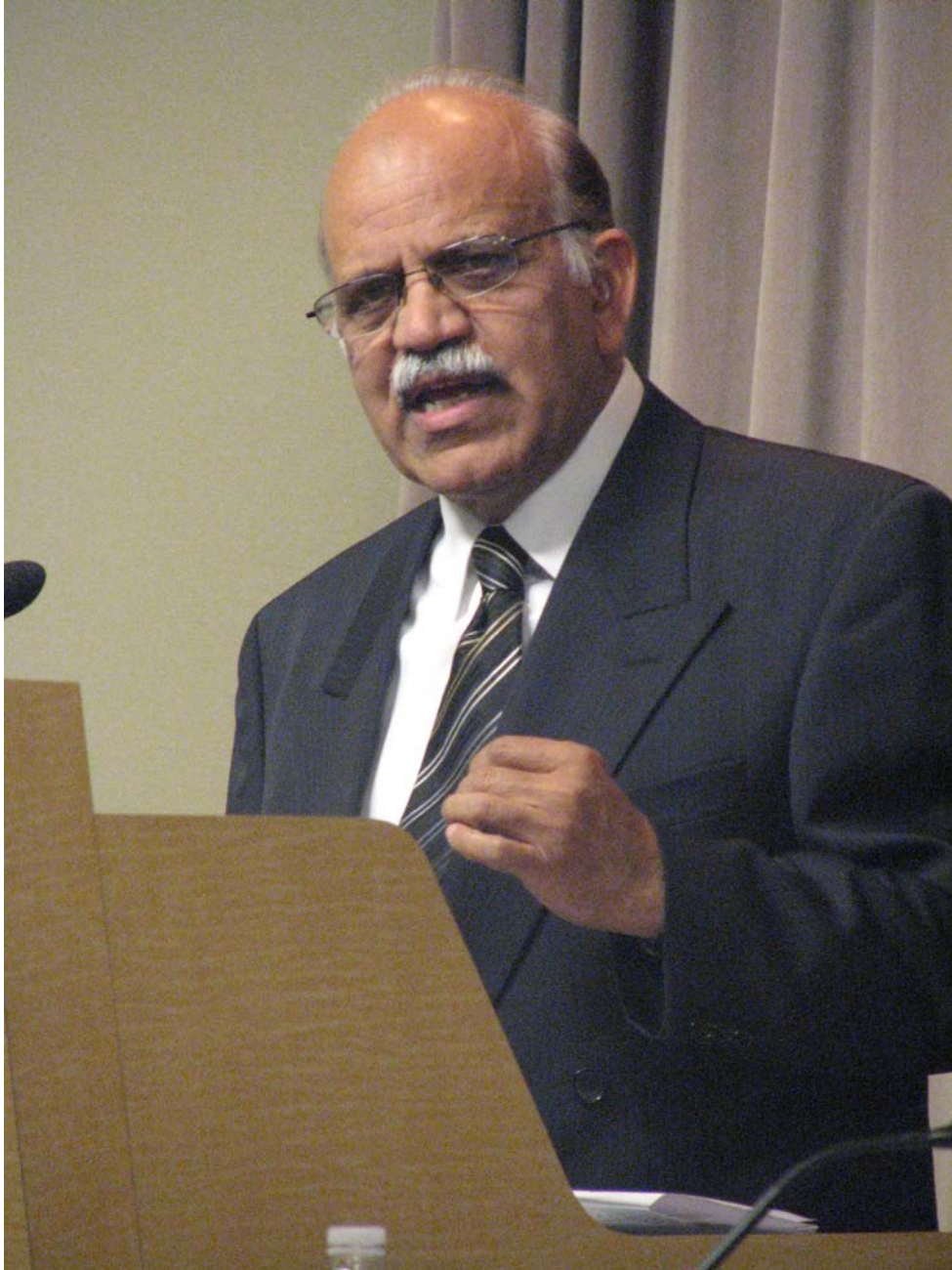


**Vote of Thanks by

Urban India alone is facing a housing shortage of about 27 million units, nearly all of which are in the Economically Weaker Sections of Society. This remains the main challenge in nearly all major metropolitan cities of the region from Kabul to Karachi, Mumbai, Dhaka, Manila and Jakarta. I always say that “Issues we know, Answers we need” and that the time has come for Pro-Poor housing to take the spotlight.
